Commissioner Moore moved to approve the adjustment to keep consistent with neighboring property adjustments for Joan Laur, Parcel: RP18N03E027205, to the land at \$217,500, the improvement value \$78,200, for an overall \$295,700. Chairman Cruickshank seconded and the motion carried.
