Meeting called to order by Chairman Cruickshank at 9:00 a.m.

Commissioner, Bill Willey led the Pledge of Allegiance.

Chairman Cruickshank presented the commissioners' agenda for November 26, 2018. Commissioner Hasbrouck made a motion to approve the commissioners' agenda for November 26, 2018 as presented. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to approve the commissioners' agenda for November 26, 2018 as presented.

Senior Deputy Clerk, Jennifer Morgan presented the commissioners with Fiscal Year 2019 Claims, Board Order Claims and one Junior College Application.

Commissioner Willey made a motion to approve the Fiscal Year Claims for 2019, Board Order Claims and the one Junior College Application. Commissioner Hasbrouck seconded the motion. No further discussion, all in favor. Motion passed to approve the Fiscal Year Claims for 2019, Board Order Claims and Junior College Application for Ms. Victoria Moss.

Assessor, June Fullmer reported to the commissioners that she had met with several organizations including the State of Idaho regarding park models. She advised that it was a productive meeting. She reported that she would be closing the McCall DMV on Christmas Eve. June provided a brief overview regarding the accounting of park models and how they will be assessed and/or licensed.

Clerk, Douglas Miller presented to the commissioners on buildings and grounds matters. He also reported on potential matters on the ballot in March of 2019 and May of 2019. He reported that the outside auditor would be conducting the audit on January 15th through January 18th of 2019. He also advised that he was working with Department Heads on completing required year end reports.

Prosecuting Attorney, Carol Brockmann provided the commissioners with an update regarding criminal cases that the Prosecuting Attorney's Office had been handling over the past several months and advised that there might be increased cost for prosecution due to the nature of the cases. She advised that there were jury trials scheduled for January of 2019. She reported that she was attending the Newly Elected Official conference in Boise, Idaho and reported on an additional conference that she would be attending regarding civil matters. Carol also explained that she was working on obtaining a Governor's Warrant for an individual that was detained in North Dakota. She advised that the Prosecuting Attorney's Office was also working on a no spray contract related to the weeds in Valley County and explained the need for the contract.

Sheriff, Patti Bolen reported on the Turkey for Tickets program in honor of Ms. Jan West. She reported that 76 turkeys were handed out instead of tickets during the event.

Treasurer, Glenna Young reported that the Treasurer's Office had been continuing to process tax payments. Glenna presented Tax Cancellation for \$309.76 for the Tax Deed Property that sold Parcel# RPM0000085743. Commissioner Willey made a motion to approve Tax Cancellation 19-01 for Parcel# RPM0000085743. Commissioner Hasbrouck seconded the motion. No further discussion, all in favor. Motion passed to approve Tax Cancellation 19-01 for Parcel# RPM00000085743.

Glenna provided a brief overview regarding the Solid Waste Transfer Site.

Building Official, Annette Derrick provided an overview of what she had been informed about the completion of the buildings at Tamarack since the report of the sale. She advised that she had been working with the IT Department regarding advancements with technology for the Building Department.

Court Services Director, Skip Clapp presented the 2018 Juvenile Justice Annual Financial Report for the commissioners to review and consider approval. Commissioner Hasbrouck made a motion to approve the 2018 Juvenile Justice Annual Financial Report. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to approve the 2018 Juvenile Justice Annual Financial Report.

Human Resource Director, Pat Duncan informed the commissioners about openings within Valley County and the process to fill the opened positions. She reported that she was continuing to work on the employee recognition program.

University of Idaho Extension Educator, Melissa Hamilton reported on the work that she had been conducting the past several weeks. She reported on the formal year end reports that she had completed. She also discussed the planning stage for programs in 2019. She advised that the University of Idaho Extension Office had been conducting afterschool programs. She explained that Brie had been plugged into the afterschool programs. Melissa discussed the After Market Sales Committee for the 4-H Program and advised that she would follow up to determine if the kids had received their money for the sale of their 4-H animals.

IT Director, David Crawford provided the commissioners with an update of IT projects that had been completed. He reported on the ITD connection that had been down for the past several days and explained the testing that he had conducted to determine that the issue was not internal. He explained that Frontier had also been working on the issue. He advised that he had also been working with Human Resources regarding new IT Policy. He advised that he would be in Boise on Thursday for the DIGB Meeting.

Planning & Zoning Administrator, Cynda Herrick presented to the commissioners on planning & zoning matters. She reported that North Lake Sewer & Water District was not allowing RV Camping on sites within their district unless they hook into their sewer system and she wanted the commissioners to be aware. She reported on the new representative for FEMA who was responsible for the review of the Valley County Floodplain Ordinance.

Recreation Director, Larry Laxson provided the commissioners with an overview of the meetings that he had attended over the last two weeks. He reported that he was elected to be a part of the steering committee for the Payette National Forest Coalition. Larry reported that the ISSA Annual Convention would be returning to McCall. Larry advised that the Big Creek Yellow Pine Collaborative might be finishing and have made a final consensus to present to the Payette National Forest. Larry reported on the hiring process for the Snow Grooming Program.

Road Superintendent, Jeff McFadden reported on the progress that had been made on Warren Wagon Road. He advised that the Road Department had been preparing for winter operations. Jeff presented on requests that the Road Department had been receiving for winter maintenance including Willow Road. He provided a location of the area and was asking the commissioners for direction regarding to provide winter maintenance or not. He advised of the areas that the Road Department currently maintains on Wagon Wheel. Commissioner Hasbrouck made a motion to allow the Road Department to perform winter maintenance on Willow Road and classify the road as a Class C Road. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to allow the Road Department to perform winter maintenance on Willow Road and classify the road as a Class C Road.

Mr. Jay Jacques who resides on No Business presented to the commissioners regarding that land that he had purchased and explained that he had formally move to the area full time. He provided a brief over of the presentations that he has made to the commissioners in the past regarding snow removal. He now explained that he has also purchased equipment to conduct snow removal on No Business. He reported that his property was a half of mile from the start of the intersection. Chairman Cruickshank asked about the road width. Road Superintendent, Jeff McFadden provided the width to the commissioners. Mr. Jay Jacques reported that he was prepared to conduct the snow removal of the county road. It was advised that if Mr. Jacques handles the snow removal he would be accepting some liability. The discussion continued regarding the wording of a proposed agreement between Valley County and Mr. Jay Jacques.

Chairman Cruickshank advised that the commissioners had been informed that there were no matters that needed to be presented under Executive Session per Idaho Code 74-206 1(d)-Indigent & Charity.

Chairman Cruickshank presented the commissioner meeting minutes from November 19, 2018. Commissioner Hasbrouck made a motion to approve the commissioner meeting minutes from November 19, 2018. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to approve the commissioner meeting minutes from November 19, 2018.

Chairman Cruickshank presented the request for Reimbursement for IDPR Grant MV 19-3-43-1 Valley County Search and Rescue. Commissioner Hasbrouck made a motion to approve the reimbursement for IDPR Grant MV 19-3-43-1 Valley County Search and Rescue. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to approve the reimbursement for IDPR Grant MV 19-3-43-1.

Chairman Cruickshank began the discussion related to a letter of support for the McCall Police Department for the July 4th Event. Commissioner Hasbrouck made a motion to prepare a letter of support for the McCall Police Department for the July 4th Event. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to prepare a letter of support for the McCall Police Department for the 4th of July Event.

Chairman Cruickshank began the discussion related to setting the hours of Valley County Office for December 24, 2018. Commissioner Hasbrouck made a motion to authorize the closure of non-essential offices at 12:00 p.m. on December 24, 2018. Commissioner Willey seconded the motion. Chairman Cruickshank wanted to make sure that there was a notice in the

paper to inform the General Public. No further discussion, all in favor. Motion passed to authorize the closure of non-essential offices at 12:00 p.m. on December 24, 2018.

Chairman Cruickshank began the discussion to setting a date for appeal of C.U.P. 18-14 for the retreat at Boulder Lake. Planning & Zoning Administrator, Cynda Herrick reported that it would not be fair to the public to set the appeal for December 24, 2018. The commissioners requested setting an appeal date for January 22, 2019, for C.U.P. 18-14 Appeal at 1:00 p.m.

Chairman Cruickshank began the discussion related to setting the commissioners' agenda for January of 2019 through March of 2019. The commissioners set the commissioners' agenda for January 7th, 14th, 22nd and 28th. The commissioners' agenda for February 2019 would be 4th, 11th, 19th and 25th. The commissioners' agenda for March 2019 would be 4th, 11th, 18th and 25th.

Executive Director for West Central Economic Development Council, Andrew Mentzer presented to the commissioners a request for engineering costs for the North Lake Sewer & Water Septic Enhancement Project. He provided the commissioners with an overview of the GEM Grant that would be applied for through the Idaho Department of Commerce and the discussions with North Lake Sewer and Water District. Mr. Travis Prior with North Lake Sewer and Water District reported that he had Keller Engineering provide an estimate cost to conduct the engineering survey and it would cost approximately \$35,000. North Lake Sewer & Water District requested \$35,000 from Valley County for the cost of an engineering survey. The commissioners asked several questions regarding the operations and Mr. Prior provided an overview of the process to accept septic waste. Mr. Prior advised that it was a regional issue and North Lake Sewer & Water District wanted to participate to provide a solution. The discussion continued regarding where to access the funding for the engineering survey from Valley County. Planning & Zoning Administrator, Cynda Herrick provided her opinion and suggested a long term agreement be developed between North Lake Sewer & Water District and Valley County to accept septic waste for an indefinite period of time. Commissioner Hasbrouck made a motion to make a contribution of \$35,000 out of the Economic Development Expense Line to North Lake Sewer & Water District for the cost of the engineering survey with Keller Associates upon the signing of an agreement between North Lake Sewer and Water and Valley County. Commissioner Willey seconded the motion. The commissioners continued further discussion about the benefit of Valley County to pursue the construction of enhances septic system. No further discussion, all in favor. Motion passed to make a contribution of \$35,000 out of the Economic Development Expense Line to North Lake Sewer & Water District for the cost of the engineering survey with Keller Associates upon the signing of an agreement between North Lake Sewer and Water District and Valley County.

The commissioners recessed for lunch at 12:00 p.m.

The commissioners returned from lunch at 1:00 p.m.

Chairman Cruickshank reopened the Public Hearing Continuation for the Valley County Comprehensive Plan at 1:03 p.m. and asked for a staff report from Planning & Zoning Administrator, Cynda Herrick.

Planning & Zoning Administrator, Cynda Herrick provided an update staff report regarding the recommend changes that were made to the Valley County Comprehensive Plan. She also

presented that all comprehensive plans need to be adopted by Resolution and she presented the proposed resolution to the commissioners.

Chairman Cruickshank closed the Public Hearing at 1:18 p.m. and brought the matter back to the commissioners for deliberations.

The commissioners appreciated the work that had been conducted by the Valley County Planning & Zoning Commissioners and others. Commissioner Willey made a motion to approve Resolution 19-3 revision of the Valley Comprehensive Plan and authorize the Chairman Cruickshank to sign. Commissioner Hasbrouck seconded the motion. No further discussion, all in favor. Motion passed to approve Resolution 19-3 revision of the Valley Comprehensive Plan and authorize Chairman Cruickshank to sign.

Planning & Zoning Administrator, Cynda Herrick began the discussion related to postings appropriate signs around the county for planning & zoning related issues. She advised that she was looking for direction from the commissioners regarding other departments posting public hearing notice signs for the Planning & Zoning Department. She explained the process that had been occurring in the past. The commissioners discussed the matter and believed that the responsibility would be on the Planning & Zoning Department to post the public notices. Cynda agreed that the Planning & Zoning Department would begin the process of posting of public notice signs. There was also discussion of allowing other departments to post the public notices when available to continue the teamwork atmosphere.

Planning & Zoning Administrator, Cynda Herrick began the discussion related to the appointment of a Planning & Zoning Commissioners. She reported that she received one application from an acting Planning & Zoning Commissioner, Mr. Scott Freeman. Commissioner Hasbrouck made a motion to appoint Mr. Scott Freeman to the Planning & Zoning Commission for a term of three years. Commissioner Willey seconded the motion. Chairman Cruickshank during discussion advised that the position had been posted since October 2018 and the only applicant was Mr. Scott Freeman. No further discussion, all in favor. Motion passed to appoint Mr. Scott Freeman to the Planning & Zoning Commission for a three year term beginning January 10, 2019.

Assessor, June Fullmer presented five value cancellations and provided a brief overview of the reasons for the requested cancellations. Commissioner Hasbrouck made a motion to approve value cancellation number 4 for Parcel #RPM0239000091A, value cancellation number 5 for Parcel #RPD00000108575, value cancellation number 6 for Parcel #RPD00000108562, value cancellation number 7 for Parcel #MHM0902000002F, value cancellation number 8 for Parcel# MHC04260010110. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to approve value cancellation number 4 for Parcel #RPM0239000091A, value cancellation number 5 for Parcel #RPD00000108575, value cancellation number 6 for Parcel #RPD00000108562, value cancellation number 7 for Parcel #MHM0902000002F and value cancellation number 8 for Parcel# MHC04260010110.

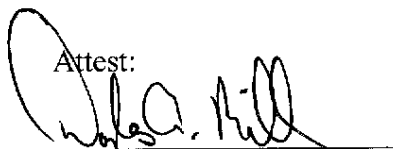

Commissioner Willey made a motion to approve the request for snow removal of Dry Buck Road and accept the road as maintenance Level C. Commissioner Hasbrouck seconded the motion. No further discussion, all in favor. Motion passed to approve the request for snow removal of Dry Buck Road and accept the road as maintenance Level C.

Corporal, Karl Kingston from Homedale Police Department was present to accept the surplus IT Equipment that the commissioners approved at the commissioner meeting on November 19, 2018.

Ms. Kristi Hamilton representing the Idaho Dog Sled Challenge presented to the commissioners regarding the Idaho Dog Sled Challenge of 2019. She provided the commissioners with a handout regarding the Iditarod Qualifier in Idaho. She also presented a case for support which provides an overview of the events that will take place in 2019. Commissioner Hasbrouck made a motion to authorize the expenditure of \$3,000 from General Fund Reserve to contribute to the Idaho Dog Sled Challenge. Commissioner Willey seconded the motion. No further discussion, all in favor. Motion passed to authorize the expenditure of \$3,000 from General Fund Reserve to contribute to the Idaho Dog Sled Challenge.

The commissioners adjourned the meeting at 3:05 p.m.

2018 McCall Ultra Sled Dog Challenge Recap



Why was the Iditarod Founded?

Since ancient times working sled dogs were the means of winter transport in the vast arctic regions of the northern hemisphere. However, with the advent of the snowmobile the sled dog became obsolete and their decline was inevitable.

So a few Alaskan's lead by Joe Reddington "Father of the Iditarod" decided to do something about it, and thought an epic race might be the inspiration needed to bring the sled dog back. Thus the Iditarod was founded.

2018 Inaugural McCall Ultra Sled Dog Challenge

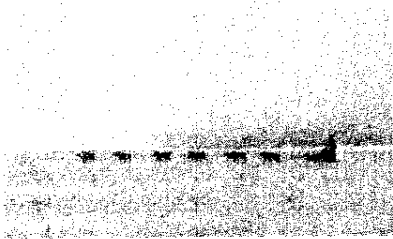
- 10 professional teams completed in the 2018 race. Three have completed the Iditarod, one 16 times as a top contender.
- The community was on fire and discovered that this is much more than just a dog race. Passions were ignited.
- Over 125 dedicated volunteers helped make the 2018 race a major success.
- The pre race Ceremonial Start drew the largest attendance of any event in Ponderosa State Park's history according to the park manager, with over 900 cars entering the park and with 2,000 spectators.
