## C.U.P. 20-35 Snow Bike Race Event

in the NE ¼ Section 24, T.16N, R.3E,  
Boise Meridian, Valley County, Idaho.

**Project Description:** R&R Promotions LLC is requesting a conditional use permit for a public event on Saturday, January 30, 2021, and then on an annual basis.

This would be the 14<sup>th</sup> annual McCall Winter Carnival Snow Bike Race. This event ran at the McCall Golf Course from 2009 to 2015 and then at the Riverfront Park in McCall from 2016 to 2020. 400-800 total people are expected to attend.

No dirt work would be done. This is an on-snow event, similar to a motocross on snow, using bumps, jumps, and turns on a 1-mile track built with a snow groomer.

Parking for at least 250 cars would be available on frozen, flat ground. Portable toilets would be available at the site.

Access would be from Highway 55, Farm-to-Market Road, Barker Lane, and Gold Fork Road.

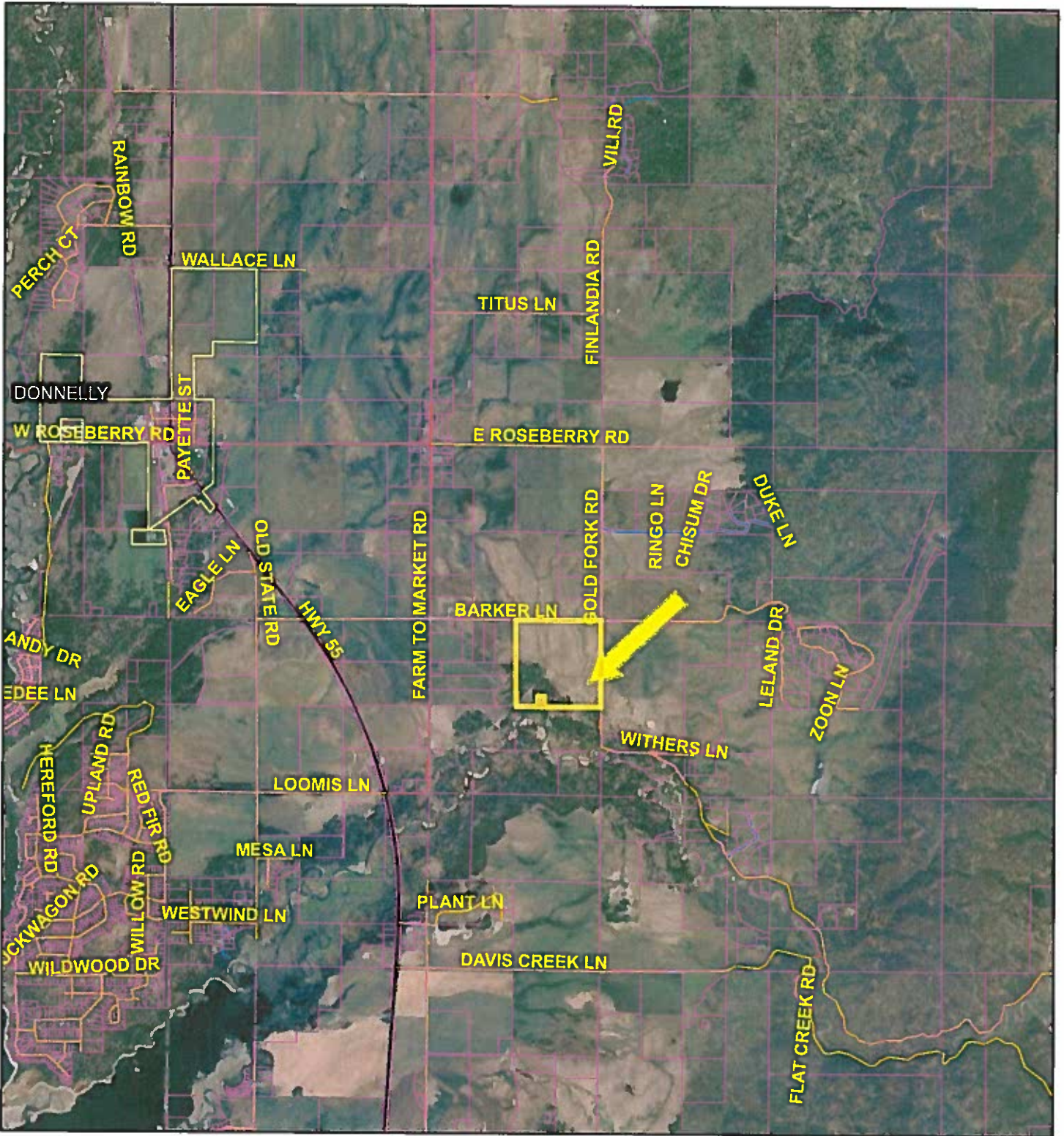

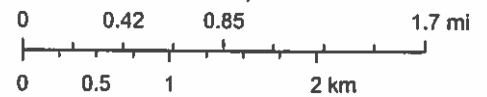
