Parks and Recreation Rules and Fees

AN ORDINANCE TO PROVIDE FOR FEES AND RULES AT CAMPGROUNDS, RAFT LAUNCHES, AND DESIGNATED PARKING AREAS; AND, PROVIDING THE EFFECTIVE DATE THEREFORE.

CHAPTER 2 Campgrounds

SECTION:

13-2-1: Fee Required for Designated Campgrounds

13-2-2: Campground Rules

13-2-3: Penalty

13-2-1: Fees Required for Designated Campgrounds - All users of Valley County operated or owned campgrounds as designated in a subsection of the Parks and Recreation Fee Schedule shall pay a day use fee or overnight fee as adopted by resolution of the Board of County Commissioners.

13-2-2: Campground Rules:

- A. Use can only be for a maximum of fourteen (14) days, whether occupied by a recreation vehicle or a tent.
- B. Quiet Hours in all campgrounds are from 10 pm to 8 am.
- C. All pets must be leashed.
- D. Trash must be hauled out – “Pack it In, Pack it Out”.
- E. Users shall not remove vegetation within the campground.
- F. Parking:
 - 1. Shall only be in designated areas.
 - 2. Shall not be in driveway to camping spots.
- G. Campfires:
 - 1. Shall not be left unattended.
 - 2. Shall be fully extinguished when not attended.

13-2-3: PENALTY:

- A. Violators of this ordinance may be asked to vacate the campground.
- B. Any violation of this chapter shall be punishable as an infraction as provided in section 1-4-1 of this code. (Ord. 14-01, 6-16-2014)

CHAPTER 3 Raft Launches

SECTION:

13-3-1: Fee Required for Raft Launches

13-3-2: Raft Launch Rules

13-3-3: Penalty

13-3-1: Fees Required at Designated Raft Launches - All users of Valley County operated or owned raft launch areas as designated in a subsection of the Parks and Recreation Fee Schedule shall pay a day use fee as adopted by resolution of the Board of County Commissioners.

13-3-2: Raft Launch Rules:

- A. Cannot block launch area.
- B. Must be prepared to unload when backing in to the launch area.
- C. No overnight parking is allowed.
- D. Concessionaires must have an Memorandum of Agreement with the Board of County Commissioners.
- E. Must remove all garbage – “Pack it In - Pack it Out”.
- F. Cannot block a public right-of-way.
- G. All pets must be leashed.

13-3-3: PENALTY:

- A. Violators of this ordinance may be asked to vacate the raft launch area.
- B. Any violation of this chapter shall be punishable as an infraction as provided in section 1-4-1 of this code. (Ord. 14-01, 6-16-2014)

CHAPTER 4

Designated Parking Areas

SECTION:

13-4-1: Fee Required for Designated Parking Areas

13-4-2: Parking Area Rules

13-4-3: Penalty

13-4-1: Fees Required for Designated Parking Areas - All users of Valley County operated or owned Parking Areas as designated in a subsection of the Parks and Recreation Fee Schedule shall pay a day use fee or overnight fee as adopted by resolution of the Board of County Commissioners.

13-4-2: Parking Area Rules:

- A. Outfitters are limited to one trailer left in parking area overnight.
- B. Outfitters delivering sleds for rental must remove trailer after delivery.
- C. Full-time residents of Secesh and Warren must obtain a long-term parking permit from the Parks and Recreation Director.
- D. Overnight Parking:
 - 1. Allowed only in designated areas as set by policy of Valley County Board of Commissioners or their designee.
 - 2. Cannot be for over one week per season.
- E. Parking areas cannot be used as storage areas for trailers.

13-4-3: PENALTY:

- A. Violators of this ordinance may be towed at owner's expense.
- B. Any violation of this chapter shall be punishable as an infraction as provided in section 1-4-1 of this code. (Ord. 14-01, 6-16-2014)
